The global migration limit, along with other specific restrictions to which monomers and/or additives presented in the material may be subjected, are respected in the conditions mentioned above. The statement is supported by analytical tests conducted in accordance with the Ministerial Decree 21/3/73 or based on calculations made by considering the content of the substances subjected to limits of migrations. The calculations were performed assuming that 1 kg of food come in contact with 6dm2 of packaging material.

In the product there are no substances regulated by the Reg. (EC) No. 1333/2008 and Reg. (EC) No. 1334/2008 (such substances are also called "dual use additives"). According to experimental data and/or theoretical calculations, these substances are in accordance with the provisions of art. 11, paragraph 3, letter a, b of the Reg. (EU) No. 10/2011 and of the Ministerial Decree 21/03/73.
