Heavy metals sum in Caltek PVC, of lead, cadmium, mercury, hexavalent chromium, is below to 100 mg/Kg.

Furthermore PVC does not include any substances reported in the annex VI of the CE 1272/2008, but it contains:

- 1. Tin-mono-n-octyl-tris-(2-ethylhexylthioglycolate) CAS 27107-89-7
- 2. Tin-dioctyl-bis-(2-ethylhexylglycolate)

CAS 15571-58-1

these additives are classified with the risk phrases R, N, T, Xi, Xn e H400, H410, H361, H372, H302, H317 and their total concentrations, calculated as tin, is higher than 0.1%.

In conformity to REACH regulation organic tin based stabilizer are allowed except for the uses reported in:

- a. annex XVII
- b. paragraph 20 CE 552/2009
- c. paragraph 6 del CE 76/769

Caltek srl does not make use of any "conflicts minerals" as wolframite, cassiterite, columbite-tantalite and their derivatives. All Caltek srl raw materials come from UE suppliers.

Furthermore, to the last update of 17-December-2014, Caltek srl does not make use of substances cited in the ECHA candidate list, and if they were present, they were not added intentionally.

Caltek srl has carefully checked all the safety data sheets of the raw materials to assure the conformity to REACH regulation. Caltek's production process could not induce any chemical modification to the finished product.
